AIM OF THE CONFERENCE

The EC/HMA/EMA publication in December 2023 of the first list of more than 200 active substances of medicine for human use considered critical for health systems across the EU was presented as an important tool to support the EU's efforts in ensuring supply security and preventing shortages of critical medicines.

The practical implementation of this new tool requires careful evaluation of the real impact of the potential shortage of the selected medicinal products taking into consideration their supply chain criticalities and their different distribution in the EU countries.

The purpose of this conference is to discuss the above issues with the contribution of a few representatives of European drug agencies and the presence of representatives of key stakeholders.

In the plenary session, the experiences of speakers who have already had to deal with the lists of "critical medicines" will be discussed.
